

#### NOW THIS MoU WITNESSTH AS UNDER:




2. The fee for the coaching classes to be decided later on with mutual consent.
3. Faculty of Law, Baba Mastnath University, Rohtak on its part will promote these courses among students and also ensure online hosting of these courses, in consultation with Archana's Classes for Judicial Excellence & Allied Services, New Delhi.
4. Both the parties intend to enter into an MoU to provide coaching for legal competitive exams to students of Faculty of Law, Baba Mastnath University, Rohtak in association with Archana's Classes for Judicial Excellence & Allied Services, New Delhi.



