## Admission Notice for Ph.D Programmes (Session 2024-25) – Corrigendum

This is with reference to the Admission Notice for Ph.D programme for the session 2024-25 issued in the newspaper and uploaded on the University website.

As per UGC instructions, the following categories were notified eligible for admission to Ph.D. programme: -

Category-1	Eligible for (i) admission to Ph.D. with JRF and (ii) appointment as Assistant Professor.
Category-2	Eligible for (i) admission to Ph.D. without JRF and (ii) appointment as Assistant Professor.
Category-3	Eligible for admission to Ph.D. programme only and not for the award of JRF or appointment as Assistant Professor

The matter has been considered by the University Authorities and it has been decided that if the candidates are not available from the above categories the University will conduct Entrance Test at its own level for admissions to Ph.D. programme in various subjects.

The candidates who fulfil the eligibility conditions for admission to Ph.D. programme as prescribed by the UGC, may also apply through offline mode as well as online mode upto 30-11-2024. They will be considered for admission only if seats remain vacant in various subjects of Ph.D programme.

The candidates who have already qualified the GATE/ GPAT exams conducted by the Apex bodies at National level will be exempted from the Entrance Test for admission to Ph.D programme in the concerned subjects.
