| D | Duplicate Degree   | Rs. 3000/- (Instead of Rs. 4000/-)  |
| E | Where the Convocation has already been held and some Degrees of the students (who did not attend the Convocation) are pending. | These students will pay Rs.4000/- as per Existing Rules at that time.                                     |
| F | The Convocation Fee is not refundable in any case.   |   |
